We are pleased that you/your child has decided to participate in the Skate park Programs. It is required by the City of Loudon that this Hold Harmless Release be completed by participant's parent or legal guardian if under the age of 18. The mandatory understanding concerning participation is listed as follows:

### Part One:

1. You give your child, identified on the top of this form, permission to participate at the Loudon Skate Park.
2. You agree, on behalf of yourself, your child, your assigns, executors, and heirs, to release, indemnify, and hold harmless the City of Loudon Parks & Recreation, and its officials, officers, agents and employees from any and all liability, damage, claim of any nature arising out of or in any way related to your child's participation at this skate park.
3. You state that you are aware of all the inherent dangers and risk involved in skate park participation including but not limited to: bodily injury, sprains, fractures, dislocations, lacerations, concussions, skin disease, eye, head, neck or back injuries, or death. Some specific risks include, but are not limited to:

1. Being hit or struck by sports equipment (skateboards, skates, bikes).
2. Being hit, struck, physically challenged or collision with other skate park participants.
3. Collision with skate park facilities (floor, structures, ground, rink, obstacles, boards, mat).
4. You understand that the City of Loudon does not provide any Accident or Medical Insurance and that you are required to provide this for your child. You agree that you are financially responsible for all medical expenses whatsoever.
5. You understand that the terms of this agreement are legally binding and certify that you are signing this agreement of your own free will after carefully reading it.

**Part Two: Medical Authorization**

In the event of serious illness or injury, I authorize the facility staff to transport (as deemed necessary) my child to a hospital emergency facility for treatment. All reasonable attempts to contact a parent or guardian will be made. I accept responsibility for all costs involved in the transport and treatment of my child. My hospital insurance carrier is listed above.

**Part Three: Facility Rules and Regulations**

1. Helmets must be worn at all times by all participants. Use of other protective gear is recommended.
2. Children ages under 10 must wear full protective gear (helmet/wrist/elbow/knees) and have responsible adult within a visible sight line.
3. All protective gear and equipment must be designed for skateboard/in-line skating/BMX biking and be in good condition. Loudon Skate park staff reserves the right to refuse anyone to skate if their protective gear and equipment is not adequate.
4. Prohibited activity within the skate park includes motorized equipment, alcoholic beverages, tobacco products, illegal drugs, pets, graffiti, tagging, food and beverages.
5. Participants must wear clothing appropriate to activity including shirts and closed toe shoes.
6. All skaters agree to act in an orderly, safe and considerate manner while in the Skate Park. No “snaking.” Everyone is to wait their turn. Any unsafe behavior will result in immediate expulsion and possible loss of skate park privileges.
7. Users are to immediately report any safety concerns or injuries, whether major or minor in nature to park staff. In case of a serious injury, do not move the injured person and all activity shall cease immediately.
8. Violation of rules will result in loss of skate park privileges.
